NOTES TO THE INTERIM FINANCIAL REPORT

A. Explanatory Notes Pursuant to MFRS 134

A1. Basis of Preparation

The Interim Financial Report is unaudited and has been prepared in accordance with the reporting requirements outlined in the Malaysian Financial Reporting Standard ("MFRS") No. 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Main Market Listing Requirements of the Bursa Malaysia Securities Berhad ("BMSB").

For the current quarter ended 31 March 2026, the Group recorded a revenue of RM38.943 million as compared to RM44.067 million recorded in corresponding period of the preceding financial year, representing a decrease of RM5.124 million or approximately 12% on a quarter to quarter basis mainly due to softening of demand arising from the low and medium pressure industrial rubber hose industry globally. The export market and local market contributed approximately 89% and 11% respectively to the Group's revenue.

The Group achieved PBT of RM9.611 million for the current quarter ended 31 March 2026, representing a decrease of 13% from RM11.081 million in the corresponding quarter mainly due to lower revenue recorded in the current quarter.

The Group recorded a revenue of RM83.102 million for the six (6) months period ended 31 March 2026, as compared to RM92.734 million in the corresponding period of the preceding financial year. The export market contributed approximately 90% to the Group's revenue. The export market registered a decrease of 11% while local market was fairly consistent as compared to corresponding period of the preceding financial year. The decrease in revenue from export was mainly due to continuous softening of demand from the industrial rubber hose market.

The Group recorded a PBT of RM20.118 million for the six (6) months period ended 31 March 2026 compared to PBT of RM29.185 million recorded in corresponding period of the preceding financial year, representing a decrease of RM9.067 million or 31% decrease. The lower PBT achieved in the six (6) months period was primarily due to the continuous softening of market sentiment which resulted in lower revenue.

The Group recorded a decrease in revenue to RM38.943 million for the current quarter ended 31 March 2026 as compared to RM44.159 million recorded in preceding quarter, representing a decrease of RM5.216 million or approximately 12% mainly due to continuous slowdown in demand from the low and medium pressure industrial rubber hose industry globally.

The Group recorded a lower PBT of RM9.611 million for the current quarter ended 31 March 2026 as compared to RM10.507 million recorded in the preceding quarter ended 31 December 2025, representing a decrease of RM0.896 million or approximately 9% mainly due to lower revenue recorded.

B3. Prospect

The Group remains focused, resilience and strategically adaptable to challenges such as inflationary pressures, market-related sentiment, supply chain volatility, climate change and fluctuation of foreign currency. We prioritize on prudent procurement practices, careful inventory management and cost optimisation initiatives. The Group continues to invest in enhancing operational efficiency, maintaining a stable and agile position in an ever changing environment.

Despite these challenges, the Group remains optimistic in long-term prospects. Our continuous dedication through innovation, operational efficiency and responsive market strategies ensure that the Group sustains its position as a prominent global market player.
